### **SUBMITTAL CHECKLIST**

The City has in effect the 2018 International Codes and the 2017 National Electrical Code. Please refer to these documents for preparation of your plans.

*Please allow minimum of (10) working days for review.*

The permit becomes null and void if work or construction authorized is not commenced within 180 days or if construction or work is suspended or abandoned for a period of 180 days at any time after work is commenced.

**\*Submit (2) hard copies including the following:**

□ **SIGN PLANS**

- Sign to scale, height, width and area dimensions labeled
- Materials labeled
- Exact wording, symbols, logo, & colors
- Label distance from building edge or lease space edge if attached
- Location on building if attached
- Provide building façade/ elevation area if attached
- Other information as required by city ordinance

□ **SITE PLAN**

- Location on property if detached
- Show all streets, intersections, easements, and adjacent property if detached
- Label distance from property line if attached
- All other existing signs on site shown and labeled
